**NOTICE OF MOTION**

Zeifman Partners Inc. (the "Receiver") in its capacity as Court appointed Receiver of ACS Precision Components Partnership ("ACS") will make a motion, to a Judge presiding over the Commercial List on Friday, May 28, 2010 at 9:30 a.m. or as soon after that time as the motion can be heard, at the Court House, 330 University Avenue, Toronto, Ontario.

PROPOSED METHOD OF HEARING: The motion is to be heard

- in writing under subrule 37.12.1(1) because it is on consent or unopposed or made without notice;
- in writing as an opposed motion under subrule 37.12.1(4)
- orally.

THE MOTION IS FOR

- a) an Order abridging the time for and validating the method of service of this Notice of Motion and directing that any further service of this Notice of Motion be dispensed with such that this motion is properly returnable on May 28, 2010;

- b) an Order that Aalbers Tool & Mold Inc. (“Aalbers”) forthwith deliver up possession to the Receiver of a Roller Cage Mold and related inserts (collectively, the “Mold”), built by Aalbers for ACS pursuant to Purchase Order number 331148 issued July 6, 2009 by ACS to Aalbers;
- c) Costs; and
- d) Such further and other relief as this Honourable Court deems just.

THE GROUNDS FOR THE MOTION ARE:

- a) The Mold was manufactured by Aalbers specifically for ACS. The Mold was previously in the possession of ACS and used for the production of parts for ACS’s customer, Brose Canada Inc. (“Brose”). The Mold was returned to the possession of Aalbers shortly prior to the commencement of the receivership, for reasons unknown to the Receiver. The Mold is currently in the possession of Aalbers. Despite a request by counsel for the Receiver, Aalbers has refused to deliver up possession of the Mold to the Receiver;
- b) ACS has not paid Aalbers for the Mold. It is the Receiver’s view that, notwithstanding that no payment has been made, property in the Mold has passed from Aalbers to ACS and that the Mold is the property of ACS. Aalbers disputes that position;
- c) The Receiver requires possession of the Mold on an urgent basis to produce parts for Brose. Brose incorporates the parts in seat assemblies supplied by Brose to Volkswagen for the Jetta motor vehicle currently in production at the Volkswagen assembly plant in Puebla, Mexico. Brose only has a sufficient supply of parts to last until Monday, May 31, 2010. If the Mold is not delivered up to the Receiver immediately to allow the Receiver to produce parts for Brose, the Volkswagen Jetta production line will be shut down shortly thereafter;

- d) It is not necessary to determine at this time whether the Receiver's view or Aalbers' view regarding the ownership of the Mold is correct. The Receiver seeks to have possession of the Mold delivered up to it without prejudice to any rights which Aalbers may have in the Mold. Doing so will not prejudice Aalbers and will alleviate the imminent prejudice to be suffered by Brose and its customer, Volkswagen;
- e) The terms of the Receivership Order dated May 6, 2010, including paragraphs 6, 11 and 12;
- f) Rules 1.04, 2.03, 3.02 and 37 of the Rules of Civil Procedure.
