NOTICE OF MOTION

Zeifman Partners Inc. (the "Receiver") in its capacity as Court appointed Receiver of ACS Precision Components Partnership ("ACS") will make a motion, to a Judge presiding over the Commercial List on June 10, 2010 at 9:30 a.m. or as soon after that time as the motion can be heard, at the Court House, 330 University Avenue, Toronto, Ontario.

PROPOSED METHOD OF HEARING: The motion is to be heard

- in writing under subrule 37.12.1(1) because it is on consent or unopposed or made without notice;
- in writing as an opposed motion under subrule 37.12.1(4)
- <u>x</u> orally.

THE MOTION IS FOR

a) an Order abridging the time for and validating the method of service of this Notice of Motion and the Receiver's Fourth Report and directing that any further service of this Notice of Motion and the Receiver's Fourth Report be dispensed with such that this motion is properly returnable on June 10, 2010;

- an Order that AarKel Tool & Die Inc. ("AarKel") forthwith deliver up possession to the Receiver of ten (10) Modular Inserts as specified in Schedule A to the Notice of Motion (collectively, the "Modular Inserts"), built by AarKel for ACS pursuant to Purchase Order number 331895 issued November 5, 2009 by ACS to AarKel;
- c) an Order for the issue of a Writ of Delivery with respect to the Modular Inserts;
- d) Costs; and
- e) Such further and other relief as this Honourable Court deems just.

THE GROUNDS FOR THE MOTION ARE:

- a) The Modular Inserts were manufactured by AarKel specifically for ACS. The Modular Inserts were delivered to ACS and used for the production of parts for ACS's customer, Brose North America, Inc. ("Brose"). The Modular Inserts were returned to the possession of AarKel shortly prior to the commencement of the receivership. The Modular Inserts are currently in the possession of AarKel. Despite requests by counsel for the Receiver, Aarkel has not delivered up possession of the Modular Inserts to the Receiver;
- b) It is the Receiver's view that property in the Modular Inserts passed to ACS and AarKel's rights are those of an unpaid vendor;
- c) The Receiver requires possession of the Modular Inserts on an urgent basis to produce parts for Brose. Brose will incorporate the parts into latch assemblies supplied by Brose to Ford. If the Modular Inserts are not delivered up to the Receiver immediately to allow the Receiver to produce parts for Brose, the Ford Focus assembly line in Detroit, Michigan will likely shutdown on June 16, 2010;

- d) The Receiver seeks to have possession of the Modular Inserts delivered up to it without prejudice to the rights and claims, if any, of the parties asserting a claim against the Modular Inserts. Doing so will not prejudice AarKel and will alleviate the imminent prejudice to be suffered by Brose and its customer, Ford;
- e) The terms of the Receivership Order dated May 6, 2010, including paragraphs 6, 11 and 12;
- f) Rules 1.04, 2.03, 3.02 and 37 of the Rules of Civil Procedure.
