**ORDER**

was heard this day at 330 University Avenue, Toronto, Ontario.


ON READING the Tenth Report and on hearing the submissions of counsel for the Receiver, no one else appearing although served as evidenced by the Affidavit of Maureen McLaren sworn September 6, 2011, filed;

1. THIS COURT ORDERS that the time for service of the Notice of Motion and the Motion is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.

2. THIS COURT ORDERS that the Receiver's motion for discharge shall be scheduled for Wednesday the 28<sup>th</sup> day of September, 2011, for one hour and, subject to the terms of this Order, the Receiver shall serve its Motion Record, including the Receiver's Final Report, within seven days from the date of this Order.

3. THIS COURT ORDERS that the Receiver is hereby directed to file the fee affidavits of the Receiver and its counsel (the "**Fee Affidavits**") with respect to the Receiver's motion for discharge, and the supporting detailed account statements, with Mr. Justice Newbould of the Commercial List in electronic form, but the Fee Affidavits need not be served upon the service list in this receivership proceeding.
