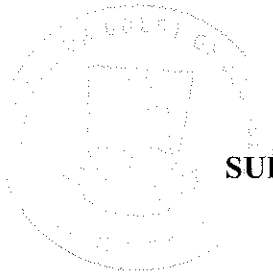

ORDER

THIS MOTION, made by Zeifman Partners Inc., in its capacity as Court-appointed interim receiver and receiver and manager (the "**Receiver**") of the assets, property and undertakings of Huronia Precision Plastics Inc. ("**Huronia**"), for:

1. An Order:
 - (a) if necessary, abridging the time for service of the Notice of Motion and Motion Record so that it is properly returnable on Wednesday April 8, 2009, and dispensing with further service thereof;

- (b) approving a distribution to Maxium Financial Services Inc. (“**Maxium**”) in the amount of \$10,140;
 - (c) approving a distribution to Gould Leasing Ltd. (“**Gould**”) in the amount of \$42,748;
 - (d) approving a third interim distribution to The Bank of Nova Scotia (the “**Bank**”) in the amount of \$566,272; and
2. Such further and other relief as counsel may advise and this Honourable Court may permit, was heard this day at 330 University Avenue, Toronto, Ontario.

ON READING the Fourth Report of the Receiver dated April 3, 2009 and all documents attached thereto, and on hearing submissions of counsel for the Receiver, and such other counsel as may be present, and on reading the affidavit of service of Goolshan Alibhai, sworn April 6, 2009, filed,

- 1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion Record is hereby abridged so that this motion is properly returnable today and any requirement for further service of the Notice of Motion and the Motion Record is hereby dispensed with.
- 2. **THIS COURT ORDERS** that the Receiver be and is hereby authorized and directed to make a distribution to Maxium, from the proceeds in the Receiver’s hands, in the amount of \$10,140.
- 3. **THIS COURT ORDERS** that the Receiver be and is hereby authorized and directed to make a distribution to Gould, from the proceeds in the Receiver’s hands, in the amount of \$42,748.
- 4. **THIS COURT ORDERS** that the Receiver be and is hereby authorized and directed to make a third interim distribution to the Bank, from the proceeds in the Receiver’s hands, in the amount of \$566,272.
