

- I am a barrister and solicitor qualified to practice law in the Province of Ontario and I am a partner with Thornton Grout Finnigan LLP ("TGF"), lawyers for Zeifman Partners Inc., in its capacity as court-appointed receiver and manager (the "Receiver") of Kobian Canada Inc. and Thinkmax Technologies Inc. and, as such, I have knowledge of the matters to which I hereinafter depose. Unless I indicate to the contrary, the facts herein are within my personal knowledge and are true. Where I have indicated that I have obtained facts from other sources, I believe those facts to be true.
- 2. Attached hereto as Exhibit "A" are true copies of the invoices issued to the Receiver by TGF for fees and disbursements incurred by TGF through the course of these proceedings between August 10, 2016 and February 14, 2018.



Without limiting the generality of the foregoing, Zeifman is hereby forever released and discharged from any and all liability relating to matters that were raised, or which could have been raised, in the within receivership proceedings, save and except for any gross negligence or wilful misconduct on the Receiver's part.
- 12. **THIS COURT ORDERS** that this order shall be binding upon Zeifman in its capacity as trustee in bankruptcy of Kobian (the "**Trustee**").

- 13. **THIS COURT ORDERS** that, upon filing of the Receiver's Discharge Certificate, the Receiver is hereby deemed to have transferred the care, custody and control of the Debtors' books and records in the possession of the Receiver to the Trustee.
- 14. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.
