withdrawal statements, bank statements, correspondence, memoranda and any other electronic or paper files related in any way to the said bank account(s).

5. THIS COURT ORDERS that any party affected by this order may apply for directions in respect of this order or to vary or set aside this order on 7 days' notice to counsel for the Receiver.
