

Notice and Statement of the Receiver (Section 245(1) and 246(1) of the Bankruptcy and Insolvency Act)

The Receiver gives notice and declares that:

1. On the 19th day of June, 2020, Zeifman Partners Inc. became the Receiver in respect of the property of 83 Lyndhurst Avenue ("83 Lyndhurst" or the "Property"), that is described below:
